# Guidance Notes on the Use of The Standard Tender Document

These guidance notes have been prepared by the CPTU to assist a Procuring Entity in the preparation, using this Standard Tender Document (STD), for the procurement of Works and physical services having estimated cost up to **BDT 3 Crore.** The Procuring Entity should also refer to thePublic Procurement Act 2006 (Act No 24 of 2006) and the Public Procurement Rules, 2008, issued to supplement the Act available on CPTU's website: http://www.cptu.gov.bd/ including amendments thereto. All concerned are advised to refer to the aforementioned Act and Rules while participating in any Tendering process

The use of STDPW2a applies when the Procuring Entity intends to select a Tenderer (a Contractor) for the Procurement of Works and physical services under Open Tendering Method (OTM), while the contract award is being determined on the basis of lowest evaluated responsive Tender.

STD PW2a is intended as a model for admeasurements contracts (unit prices in a Bill of Quantities) and the main text refers to admeasurements Contracts.

Guidance notes in brackets and italics are provided for both the Procuring Entity and the Tenderer and as such the Procuring Entity should carefully decide what notes need to remain and what other guidance notes might be required to assist the Tenderer in preparing its Tender Submission; so as to minimize the inept Tendering Process.

STD PW2ahas 9 Sections, of which Section 1: Instruction to Tenderer and Section 3: General Conditions of Contract <u>must not be altered or modified under any circumstances.</u>

The following briefly describes the Sections of STDPW2a and how the Procuring Entity should use these when preparing a particular Tender Document.

#### Section 1. Instructions to Tenderers (ITT)

The Instruction to Tenderer (ITT) specifies the instructions and procedures that govern the tendering process. This Section also contains the criteria to be used by the Procuring Entity to determine the lowest evaluated Tender and the qualifications of the Tenderer to perform the Contract. The Instructions to Tenderer (ITT) are therefore not a part of the Contract. The text of the Clauses in this Section shall not be modified.

#### Section 2. Tender Data Sheet (TDS)

This Section provides the information that is specific to each object of procurement and that supplements the information or requirements included in Section 1: Instructions to Tenderers. The Procuring Entity shall specify in the TDS only the information that the ITT instruct, be specified in the TDS. To facilitate the preparation of the **TDS**, its Clause Numbers are numbered with the same numbers of the corresponding ITT Clauses.

#### Section 3. General Conditions of Contract (GCC)

This Section provides the General Conditions of Contract that will apply to the Contract for which the Tender Document is issued. The GCC clearly identifies the provisions that may normally need to be specified for a particular tendering process and need to be addressed through the PCC. The text of the Clauses in thisSection shall not be modified.

#### Section 4. Particular Conditions of Contract (PCC)

This Section provides clauses specific to the particular Contract that modify or supplement Section 3: General Conditions of Contract. The Procuring Entity should include at the time of issuing the Tender Document all possible information that the

GCC indicated in the PCC. To facilitate the preparation of the **PCC**, its ClauseNumbers are numbered with the same numbers of the corresponding GCC Clauses.

#### Section 5. Tender and Contract Forms

#### Tender Forms

This Section provides **Form** the standard format for the **Tender Submission Letter**, (PW2a-1), **Tenderer Information (Form PW2a-2) and Bank's Commitment for Line of Credit (Form PW2a-3)**. These forms along with required documents mentioned in the ITT will constitute the Tender, to be submitted by the Tenderers.

#### Contract Forms

This Section contains the form of the **Notification of Award (Form PW2a-4)** and the **Contract Agreement (Form PW2a-5)**.

#### Section 6. Bill of Quantities

This Section provides the items and estimated quantities of Works to be performed and must be carefully prepared by the Procuring Entity for each object of procurement.

#### Section 7. General Specifications

This Section provides the General Specifications that describe the Works and physical services to be procured.

#### Section 8. Particular Specifications

This Section provides further details as to precise requirements not included in the General Specifications, or which modify or clarify the General Specifications for the particular Works and physical services to be procured.

#### Section 9. Drawings

This Section contains any Drawings that supplement the General and Particular Specifications for the Works and physical services to be procured.

### **Section 1. Instructions to Tenderers**

#### A. General

- Scope of Tender
   1.1 The Procuring Entity, as indicated in the Tender Data Sheet (TDS) issues this Tender Document for the procurement of Works and physical services incidental thereto as specified in the TDS and as detailed in Section 6: Bill of Quantities. The name of the Tender and the number and identification of its constituent lot(s) are stated in the TDS.
  - 1.2 The successful Tenderer shall be required to execute the Works and physical services as specified in the General Conditions of Contract.

### 2. Interpretation

- 2.1 Throughout this Tender Document:
  - the term "in writing" means communication written by hand or machine duly signed and includes properly authenticated messages by facsimile or electronic mail;
  - (b) if the context so requires, singular means plural and vice versa;
  - (c) "day" means calendar days unless otherwise specified as working days;
  - (d) "Person" means and includes an individual, body of individuals, sole proprietorship, partnership, company, association or cooperative society that wishes to participate in Procurement proceedings;
  - (e) "Tenderer" means a Person who submits a Tender;
  - (f) "Tender Document" means the Document provided by a Procuring Entity to a Tenderer as a basis for preparation of the Tender; and
  - (g) "Tender" depending on the context, means a Tender submitted by a Tenderer for execution of Works and physical services to a Procuring Entity in response to an Invitation for Tender.
- 3. Corrupt, Fraudulent, Collusive, Coercive (or Obstructive in case of Development Partner) Practices
- 3.1 The Government and the Development Partner, if applicable requires that the Procuring Entity as well as the Tenderers and Contracts (including sub-contractors, agents,personnel, consultants, and service providers) shall observe the highest standard of ethics during implementation of procurement proceedings and the execution of Contracts under public funds.
- 3.2 For the purposes of ITT Sub Clause 3.3, the terms set forth below as follows:
  - a. "corrupt practice" means offering, giving or promising to give, receiving, or soliciting either directly or indirectly, to any officer or employee of the Procuring Entity or other public or private authority or individual, a gratuity in any form; employment or any other thing or service of value

as an inducement with respect to an act or decision or method followed by the Procuring Entity in connection with a Procurement proceeding or Contract execution;

- b. "fraudulent practice" means the misrepresentation or omission of facts in order to influence a decision to be taken in a Procurement proceeding or Contract execution;
- c. "collusive practice" means a scheme or arrangement between two (2) or more Persons, with or without the knowledge of the Procuring Entity, that is designed to arbitrarily reduce the number of Tenders submitted or fix Tender prices at artificial, non-competitive levels, thereby denying the Procuring Entity the benefits of competitive price arising from genuine and open competition;
- d. "coercive practice" means harming or threatening to harm, directly or indirectly, Persons or their property to influence a decision to be taken in the Procurement proceeding or the execution of a Contract, and this will include creating obstructions in the normal submission process used for Tenders.
- e. "Obstructive practice" (applicable in case of Development Partner) means deliberately destroying, falsifying, altering or concealing of evidence material to the investigation or making false statements to investigators in order to materially impede an investigation into allegations of a corrupt, fraudulent, coercive or collusive practice; and /or threatening, harassing or intimidating any party to prevent it from disclosing its knowledge of matters relevant to the investigation or from pursuing the investigation.
- 3.3 Should any corrupt, fraudulent, collusive, coercive (or obstructive in case of Development Partner) practice of any kind is determined by the Procuring Entity or the Development Partner, if applicable, this will be dealt in accordance with the provisions of the Public Procurement Act and Rules and Guidelines of the Development Partners.In case of obstructive practice, this will be dealt in accordance with Development Partners Guidelines.
- 3.4 If corrupt, fraudulent, collusive, coercive (or obstructive in case of Development Partner) practices of any kind is determined by the Procuring Entity against any Tenderer or Contracts (including sub-contractors, agents, personnel, consultants, and service providers) in competing for, or in executing, a contract under public fund:
  - (a) Procuring Entity and/or the Development Partner

shall exclude the concerned Tenderer from further participation in the concerned procurement proceedings;

- (b) Procuring Entity and/or the Development Partner shall reject any recommendation for award that had been proposed for that concerned Tenderer;
- (c) Procuring Entity and/or the Development Partner shall declare, at its discretion, the concerned Tenderer to be ineligible to participate in further Procurement proceedings, either indefinitely or for a specific period of time;
- (d) Development Partner shall sanction the concerned Tenderer or individual, at any time, in accordance with prevailing Development Partner' sanctions procedures, including by publicly declaring such Tenderer or individual ineligible, either indefinitely or for a stated period of time: (i) to be awarded a Development Partner-financed contract; and (ii) to be a nominated sub-contractor, consultant, manufacturer or Contractor, or service provider of an otherwise eligible firm being awarded a Development Partner-financed contract; and
- (e) Development Partner shall cancel the portion of the loan allocated to a contract if it determines at any time that representatives of the Procuring Entity orof a beneficiary of the loan engaged in corrupt, fraudulent, collusive, coercive or obstructive practices during the procurement or the execution of that Development Partner financed contract, without the Procuring Entity having taken timely and appropriate action satisfactory to the Development Partner to remedy the situation.
- 3.5 Tenderer shall be aware of the provisions on corruption, fraudulence, collusion, coercion (and obstruction, in case of Development Partner) of the Public Procurement Act, 2006, the Public Procurement Rules, 2008 and others as stated in GCC Clause 17.
- 3.6 In further pursuance of this policy, Tenderers, Contractors and their sub-contractors, agents, personnel, consultants, service providers shall permit the Government and the Development Partner to inspect any accounts and records and other documents relating to the Tender submission and contract performance, and to have them audited by auditors appointed by the Government and/or the Development Partner during the procurement or the execution of that Development Partner financed contract.

- 4. Eligible Tenderers
- 4.1 This Invitation for Tenders is open to all potential Tenderers.
- 4.2 Tenderers shall have the legal capacity to enter into the Contract under the Applicable Law.
- 4.3 Tenderers shall be enrolled in the relevant professional or trade organizations registered in Bangladesh.
- 4.4 Tenderers may be a physical or juridical individual orbody of individuals, or company invited to take part in public procurement or seeking to be so invited or submitting a Tender in response to an Invitation for Tenders.
- 4.5 Tenderers shall have fulfilled its obligations to pay taxes under the provisions of laws and regulations of Bangladesh.
- 4.6 Tenderers and all parties constituting the Tenderer shall not have a conflict of interest.
- 4.7 Tenderer in its own name or its other names or also in the case of its Persons in different names, shall not be under a declaration of ineligibility for corrupt, fraudulent, collusive or coercive practices as stated under ITT Clause 3.4 (or obstructive practice, in case of Development Partner) in relation to the Development Partner's Guidelines in projects financed by Development Partner.
- 4.8 Tenderers are not restrained or barred from participating in Public Procurement on grounds of poor performance in the past under any Contract.
- 4.9 Tenderers shall not be insolvent, be in receivership, be bankrupt, be in the process of bankruptcy, be not temporarily barred from undertaking business and it shall not be the subject of legal proceedings for any of the foregoing.
- 4.10 Government-owned enterprise in Bangladesh may also participate in the Tender if it is legally and financially autonomous, it operates under commercial law, and it is not a dependent agency of the Procuring Entity.
- 4.11 Tenderers shall provide such evidence of their continued eligibility satisfactory to the Procuring Entity, as the Procuring Entity will reasonably request.

- 6.1 A prospective Tenderer requiring any clarification of the Tender Document shall contact the Procuring Entity in writing at the Procuring Entity's address and, within time as specified in the **TDS**.
- m to Tender7.1At any time prior to the deadline for submission of<br/>Tenders, the Procuring Entity on its own initiative or in<br/>response to a clarification request in writing from a<br/>Tenderer, may revise the Tender Document by issuing an<br/>Addendum.
  - 7.2 The Addendum issued under ITT Sub Clause 7.1 shall become an integral part of the Tender Document and shall have a date and an issue number and must be circulated by fax, mail or e-mail, to Tenderers who have purchased the Tender Documents, within five (5) working days of issuance of such Addendum, to enable Tenderers to take appropriate action.
  - 7.3 If an Addendum is issued when time remaining is less than **one-third** of the time allowed for the preparation of Tenders, the Procuring Entity at its discretion shall extend the deadline by an appropriate number of days for the submission of Tenders, depending upon the nature of the Procurement requirement and the addendum. In any case, the minimum time for such extension shall not be less than three (3) working days.

### C. Qualification Criteria

8.1 Tenderers shall possess the necessary professional and technical qualifications and competence, financial resources, equipment and other physical facilities, managerial capability, specific experience, reputation, and the personnel, to perform the contract, which

entails setting pass/fail criteria, which if not met by the Tenderers, will result in consideration of its Tender as non-responsive.

- 8.2 In addition to meeting the eligibility criteria, as stated under ITT Clause 4, Tenderers must satisfy the other criteria stated in ITT Clauses 9 to 12 inclusive.
- 8.3 To qualify for multiple number of contracts/lots in a package made up of this and other individual contracts/lots for which Tenders are invited in the Invitation for Tenders, the Tenderers shall demonstrate having resources sufficient to meet the aggregate of the qualifying criteria for the individual contracts. The requirement of general experience as stated under ITT Sub Clause 9.1(a), and specific experience unless otherwise of different nature, as stated under ITT Sub Clause 9.1(b)shall not be separately applicable for each individual lot
- 9. Experience Criteria
   9.1 Tenderers shall have the following minimum level of construction experience to qualify for the performance of the Works under the Contract:
  - (a) a minimum number of years of general experience in the construction of works as specified in the **TDS**; and
  - (b) specific experience in construction works of a nature, complexity and methods/construction technology similar to the proposed Works, in at least a number of contract(s)and, each with a minimum value over the period, as specified in the **TDS**.
  - 10.1 Tenderer shall have the following minimum level of financial capacity to qualify for the performance of the Works under the Contract.
    - (a) the average annual construction turnover as specified in the **TDS** during the period specified in the **TDS**;
    - (b) availability of minimum liquid assets i.e. working capital or credit line(s) from any scheduled Bank of Bangladesh, net of other contractual commitments, of the amount as specified in the **TDS.**
    - (c) The Minimum Tender Capacity as specified in the **TDS**.
  - 11.1 Tenderers shall have the minimum level of personnel capacity to qualify for the performance of the Works under the Contract consisting of key personnel with qualifications and experience as specified in the **TDS**.

- 20.1 Tenderers shall submit the Tender Submission Letter (Form PW2a-1), which shall be completed without any alterations to its format, filling in all blank spaces with the information requested, failing which the Tender may be rejected as being incomplete.
- **20.2** Tenderers shall submit the priced BOQ using the form(s) furnished in **Section 6: Bill of Quantities.**
- 20.3 If in preparing its Tender, the Tenderer has made errors in the unit rate or the total price, and wishes to correct such errors prior to submission of its Tender, it may do so, but shall ensure that each correction is initialled by the authorised person of the Tenderer.

## **Section 8. Particular Specifications**

- 1. The work shall be executed in accordance with the specifications laid down in BOQ with specifications given here in under and/ or specifications shown in the drawings. The method of construction employed and workmanship should be in accordance with the current recognized practice and principles.
- 2. Construction are obliged to make detailed specification of sites and proposed works before tendering and satisfy themselves as to the nature of works and sites, scope of work, local facilities of access and approach and other matters affecting the execution of the work. The tendered rates include all such incidentals and contingencies. Nothing will be awarded as compensation for any misunderstanding arising afterward in respect of the above-mentioned matters.
- 3. The site will be cleared of all rubbish, spoils, overburden etc. and made level at their own cost as directed by the Authority.
- 4. Excavation for foundation trenches and for other purposes shall be done exact to the size at the places marked on the ground. Care should be taken so that the bottom is properly levelled. both longitudinally and transversely and the dimension are at any point not less than specified. #### 5. <u>Coarse Aggregate and Sand</u>:

a. Coarse aggregate for all for all RCC and PCC Works wherever shown in the drawings shall be of Crushed stone aggregate as specified in drawings as approved by the User. Sand Shall be 100% Sylhet/ Domar FM 2.50 RCC work or as shown in drawings. The grading shall be as specified by Project Manager. Aggregate shall be washed before use. Sand for brickwork & plaster shall be of FM-1.5 No extra payment on account of additional cost of sand shall be admissible.

b. For all RCC/PCC/BB/Plaster works, river/pit sand duly approved by the User shall be used. It shall be free from all types of organic impurities. It shall pass through a 5mm mesh and be almost entire retained on a No. 100 mesh not more than 3% passing through. It should not contain any dirt. Sand containing sulphates must never be used.

c. Proportion of RCC & PCC works shall be done as per bills of quantities/ of drawing or as per PWD Schedule of Rates 2022 or otherwise specified.

6. <u>**Timber**</u>: All timber except in joinery shall be first class soft wood Ctg silkorai/Ctg Gamar well-seasoned unless otherwise specified in the drawings and approved by the User. Doors/window/CSW/cat door shall be made of Ctg Silkorai/Ctg Gamar wood well-seasoned unless otherwise specified in the drawings and approved by the User. Timber to be brought at site after 1<sup>st</sup> RAR. Otherwise, 2<sup>nd</sup> RAR will not be allowed. Hard wood wherever specified shall be silkorai wood seasoned and approved by the Project Manager. Exposed surfaces shall be wrought and hidden surface shall be clean swan and coated with bitumen or coaltar. Stair nosing shall be done as per drawing or otherwise specified.

7. Contractor will take all kinds of safety & security measure to avoid any accident as per Bangladesh National Building Code 2020 & followings:

a. One fixed safety tray at suitable level and one mobile safety tray shall be fixed made by 50x50x3 mm and 25x25x3 mm angle 10mm die tie rod, required size of royal bolt, 26 BG CGI sheet & others fittings/fixture including necessary welding all complete around the under construction building as direction of User.

b. Helmet and safety belt must be provided by the contractor to the workers for use during working time.

c. Contractor shall provide cautionary sign boards if there is a road around the under constructor building and shall engage security workers, if necessary, at his own cost.

d. Contractor shall provide hessian cloth around the under construction building at his own cost.

e. The tray will be dismantles & taken away by the supplier after finishing the project at his own cost.

- 8. Any changes in drawing, specification mentioned above or specification laid down in PWD Schedule of Rates 2022 shall be carryout with the approval of competent authority. Drawings which are not listed in Section-9 of the CA but become necessary for the execution of work to be prepared & supplied by the User with the approval of Procuring Entity.
- 9. The method of work and workmanship should be in accordance with the current recognized engineering practice and principles.
- 10. The work shall be executed according to the instruction and specification of manufactured Catalogue should be attached with tender. All fire pump/fighting equipment's and fittings/fixtures shall be brand new and confirm to the standard design and specification of the local Fire Brigade Authority.

#### 11. Insurance:

a. The contractor shall provide, in the joint names of the Procuring Entity and the Contractor, insurance cover from the Start Date to the end of the Defects Liability Period, in the amounts and deductibles specified in the PCC for the following events which are due to the Contractor's risks:
